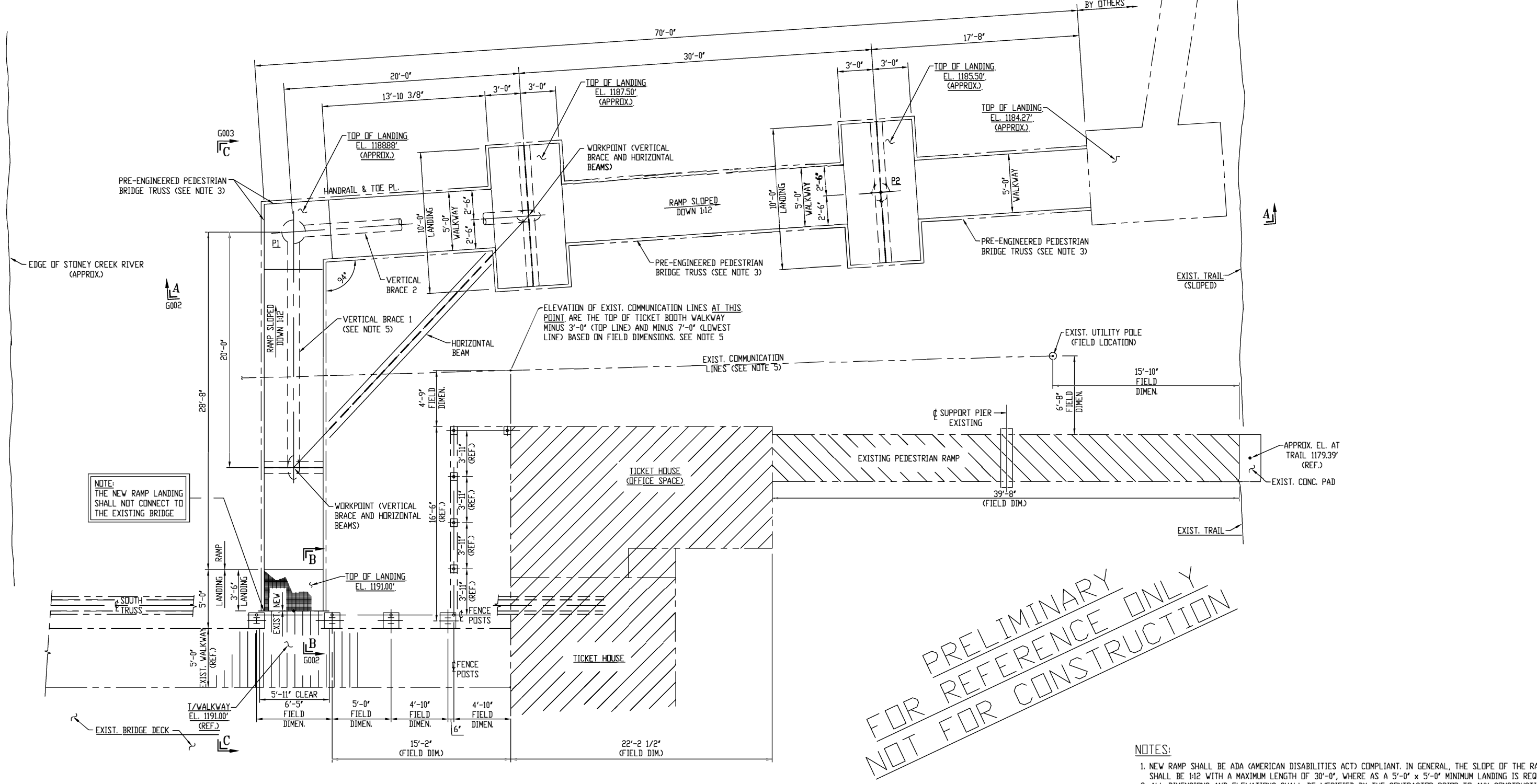

- NOTES:
1. NEW RAMP SHALL BE ADA (AMERICAN DISABILITIES ACT) COMPLIANT. IN GENERAL, THE SLOPE OF THE RAMP SHALL BE 1:12 WITH A MAXIMUM LENGTH OF 30'-0", WHERE AS A 5'-0" x 5'-0" MINIMUM LANDING IS REQUIRED.
  2. ALL DIMENSIONS AND ELEVATIONS SHALL BE VERIFIED BY THE CONTRACTOR PRIOR TO ANY CONSTRUCTION.
  3. PRE-ENGINEERED PEDESTRIAN BRIDGE TRUSS SECTION AND LANDINGS TO BE PROVIDED BY OTHER CONTRACTOR.
  4. SEE COMMONWEALTH OF PENNSYLVANIA DEPARTMENT OF TRANSPORTATION DRAWINGS S-23070 SHEET 1 THRU SHEET 29.
  5. IMPORTANT - THE EXISTING COMMUNICATION LINES WILL REMAIN IN PLACE AND IN SERVICE THROUGHOUT THE DURATION OF THE PROJECT. CONTRACTORS SHALL USE EXTREME CAUTION AND CAREFUL PLANNING DURING ALL PHASES OF CONSTRUCTION OF THE WALKWAY RAMP TO ENSURE THE COMMUNICATION CABLES ARE NOT DISTURBED OR DAMAGED IN ANY WAY. LINES WILL BE LOWERED BY UTILITY PRIOR TO CONSTRUCTION.
  6. ALL HANDRAIL SHALL BE OSHA COMPLIANT.

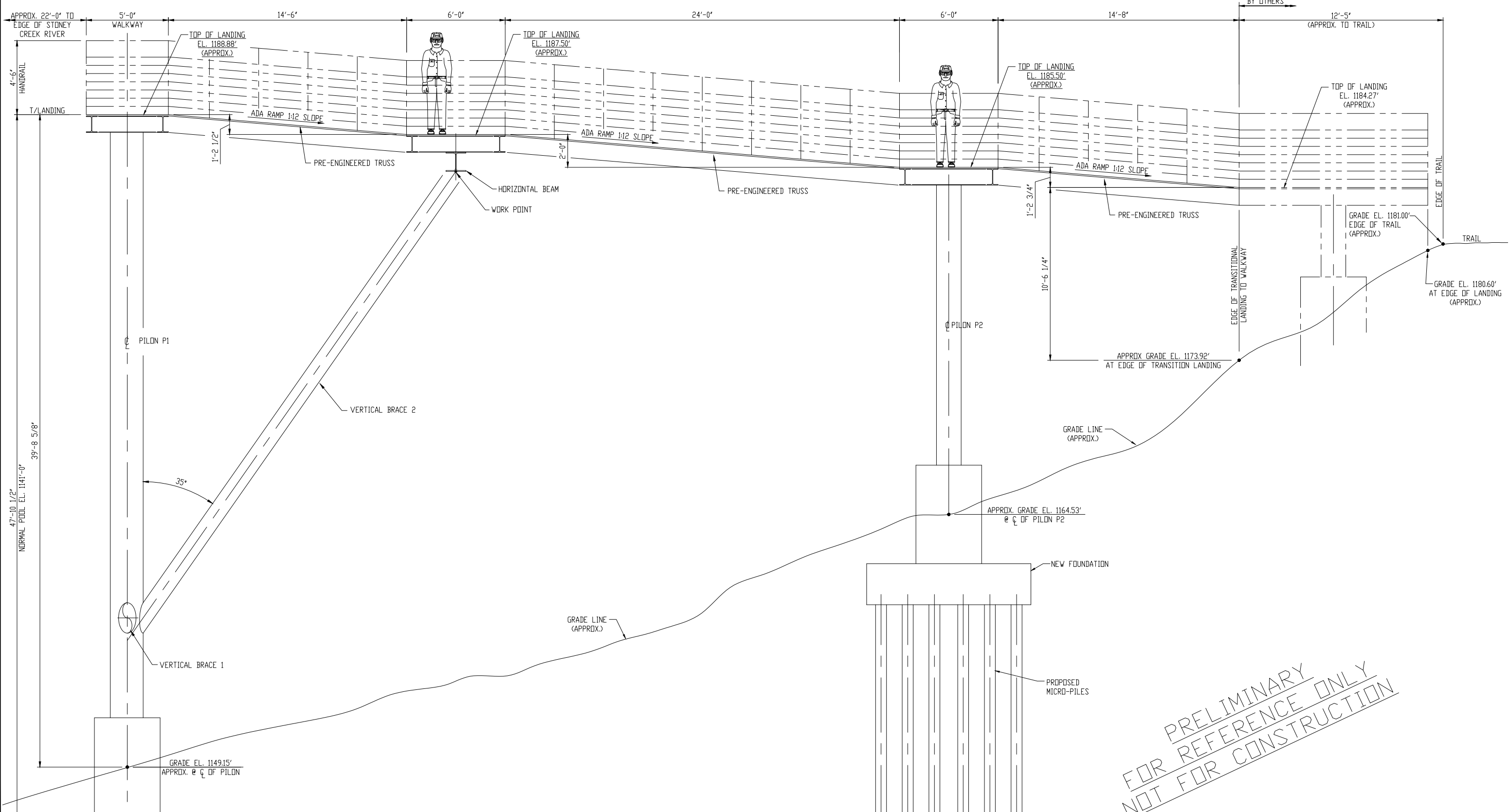

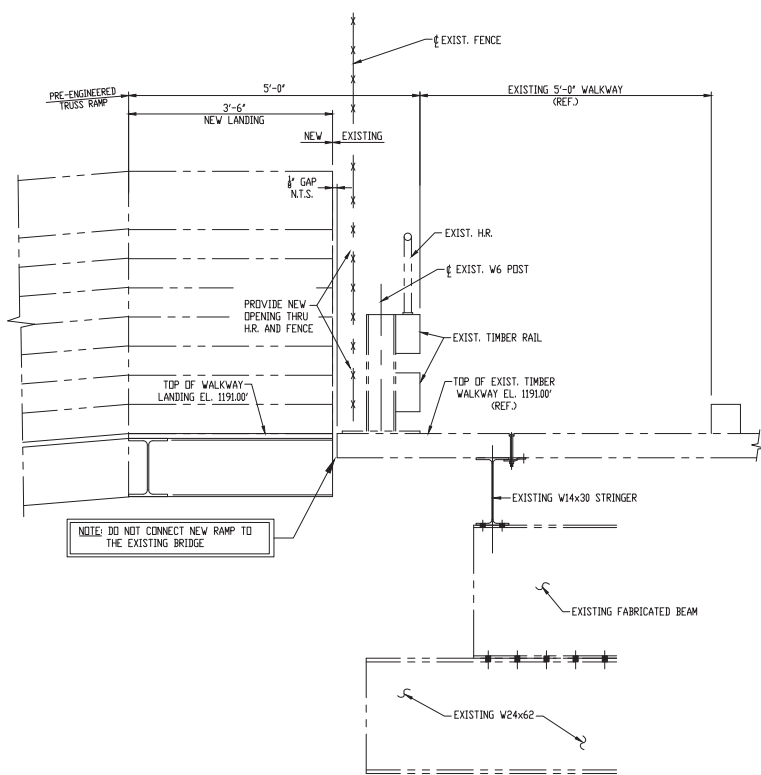

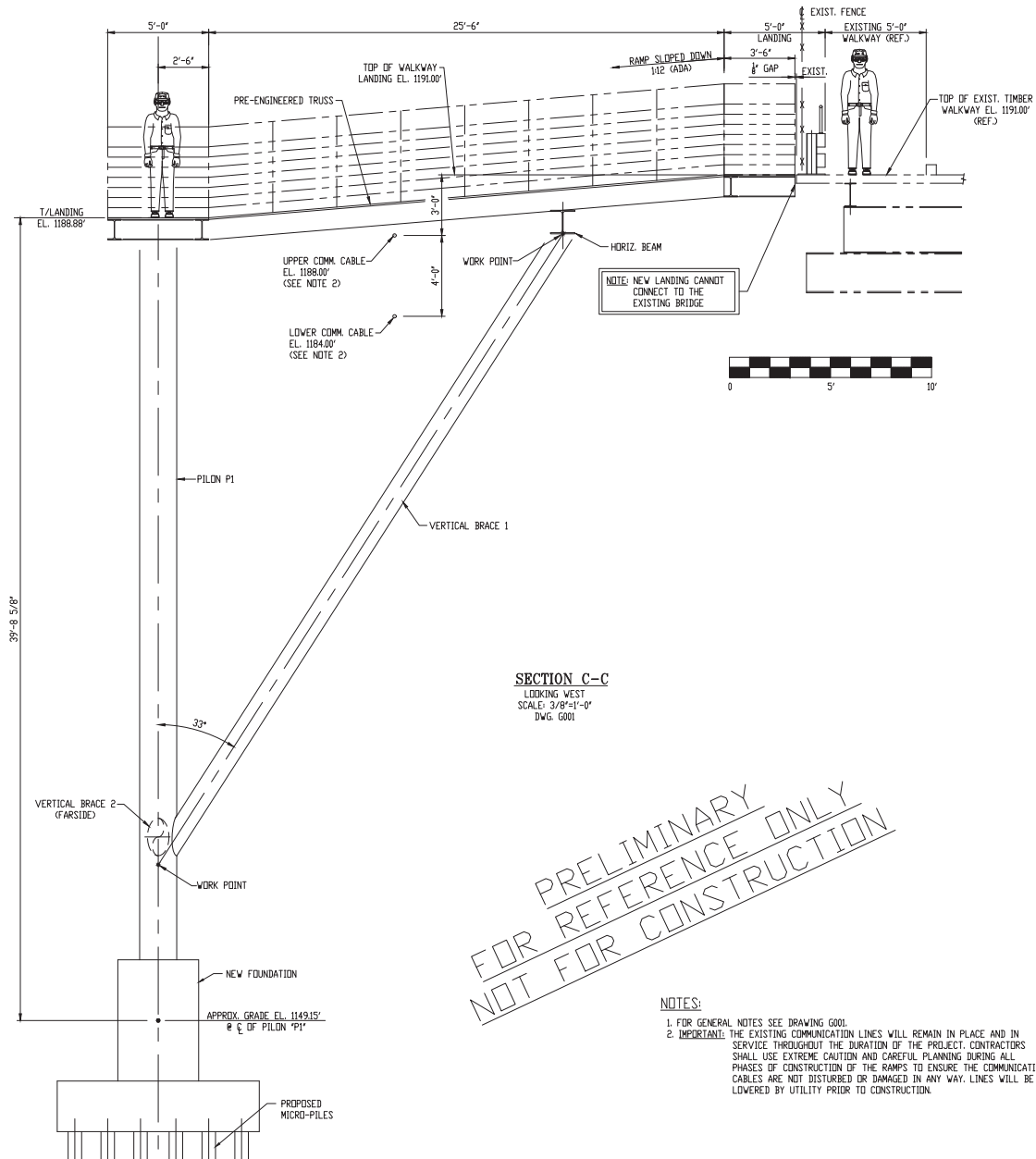
